Any information other than that asked for on the CAF or SIF will not be considered by governors.

The Governors strongly recommend that the SIF is completed and returned directly to the school by the published closing date as detailed on the admissions policy for the year of application; this is in addition to the Local Authority's application form. All information given is stored in the strictest confidence.
